Sri Siddhartha Academy of Higher Education invites your kind attention to an admission counseling of stray vacant seat/s in MBBS program offered by Sri Siddhartha Institute of Medical Sciences & Research Centre at T-Begur, after the Mop-Up rounds conducted by the Central Counseling Authority, Directorate General of Health Services, (DGHS) The counseling will be conducted as per their instructions.

1). Report and Counseling cum Admission Schedule:

The interested eligible candidates shall report to counseling, along with either of the parent requisite fees and original documents as shown below. The admissions will be granted to the candidates on the basis of inter-se merit amongst the candidates present on the said date and time. No cancellation will be entertained after this admission.

2). Counseling Procedure: Candidates attending counseling should satisfy the eligibility requirement as per the UG NEET - 2019 Information Brochure of SSAHE and the minimum eligibility requirements as prescribed by the Medical Council of India regulations for admission to UG Medical course.

(A). Come prepared for Counseling: The following original documents are to be submitted for verification during Counseling:

- 1) NEET UG 2019 Qualified Marks / Rank Card
- 2) S.S.C. / 10th Standard Statement of Marks
- 3) H.S.C. / 12th Standard / Equivalent Examination Statement of Marks
- 4) Leaving / Transfer Certificate
- 5) Bonafide and character certificate from Head of Institution last attended.
- 6) Certificate of Age (S.S.C. or 10th Passing Certificate / Valid passport)
- 7) Caste & Caste validity certificate (by candidates belonging to all Backward class)
- 8) Aadhar Card of the student – Copy
- 9) Migration certificate - Original + 3 copies (other than Karnataka board candidates)
- 10) Physical fitness certificate
- 11) 8 passport size and 8 stamp size photos
- 12) Bank Guarantee (Annexure-I) - As per format furnished in MCC/SSAHE website for the rest of the course fees payable.
- 13) Three self attested photo copies separate sets of above all documents as per above sequence.
- 14) Demand Draft of Tuition Fees, Other Fee and University Fee.

In addition to the above, the NRI Applicants would have to submit the following additional documents.

- 1) Affidavit of the person who is NRI and the sponsorer.
- 2) Documents claiming that the sponsorer is an NRI (Passport, Visa of the sponsorer)
- 3) Affidavit from the sponsorer that he/ she will sponsor the entire course fee of the candidate.
- 4) Embassy Certificate of the Sponsorer.
- 5) Citizenship of the candidate if holding OCI/PIO
- 6) Relationship with NRI with the candidate as per the court order of Hon'ble Supreme court of India in the case W.P (C) no. 689/2017 – Consortium of Deemed Universities in Karnataka (CODEUNIK) & Anr. Vs Union of India & Ors dated 22.08.2017
- 7) The degrees/Certificates of the candidates must have been recognized and approved by the Association of Indian Universities (AIU) if the qualifying examination is other than the 10 + 2 of India.

The candidates who are claiming to be eligible for admission under NRI quota, has to fulfill the eligibility criteria, as per the directions/orders of the Hon'ble Supreme Court of India

Who can sponsor under NRI Seat:

Sl. No.	Eligibility
1	Mother or Father of the student
2	Real Brother and Sister of the student
3	Real Brother and sister of Father or Mother i.e real uncle and real aunt of the student
4	Father and Mother of Father or Mother of the student i.e. Grand parents
5	First degree – paternal and maternal cousins of the student.

Important Note: NRI Applicants:

- 1) The person sponsoring should hold NRI status and residing abroad and such person should have looked after the student as the guardian. A Notarized Affidavit to that effect should be submitted at the time of admission on a twenty rupee stamp paper.
- 2) NRI quota shall include Overseas Citizens of India (OCI) and Persons of Indian Origin (PIO)
- 3) Course Fee as mentioned in the schedule should be paid in US Dollars. If It is paid in INR, then it should be paid through the NR Account of the sponsorer

IMPORTANT NOTE:

There will be active verification of the NEET All India Rank (UR) submitted by the candidate with the information available in the NEET website (ntaneet.nic.in). Candidate whose NEET All India rank does not match with the information in the NEET website will be disqualified from the counseling process.

B) On the day of Counseling:

The physical presence of the candidate at the counseling is mandatory.

- a) Only the candidate & one parent will be allowed into the counseling hall
- b) Candidate should sign the attendance register to mark their presence and submit the photo copies of the relevant documents at the registration counter. (as mentioned in 2(A)).
- c) Candidates will be called as per their NEET UG All India Rank 2019 for document verification. Successful candidates will be allotted seats according to their All India NEET (UR) rank and number of seats available. Such candidates should produce their original documents for verification and pay the first year fees & Bank Guarantee at the time of counseling. SSAHE will not entertain any requests for extension in this regard.

- d) Absence of the candidate at the indicated reporting time and date will result in the instantaneous forfeiture of any claim for a seat.
- e) The choice of course made by the candidate is final and binding and cannot be altered later under any circumstances. Once candidates get admitted to MBBS course cannot withdraw / cancel under any circumstances.

C) After Admission:

- a) Admission order/Provisional Admission Order and receipt/s for the payment made will be given to the candidate on completion of the admission process.
- b) Candidates who require hostel facility should report to Chief Warden of the allotted campus for hostel enrollment. Hostel will be allotted on payment of hostel fees only.
- c) Candidates should report to the college on or before the reporting date mentioned in the admission order.

BANK GUARANTEE FORMAT

In consideration of Sri Siddhartha Institute of Medical Sciences and Research Center (SSIMS&RC), T-Begur, Nelamangala, Karnataka a private Medical College (hereinafter called "College") having agreed to provide admission in MBBS Course to Mr./Miss..... S/o,D/o (hereinafter called "the said student"), a Bank Guarantee for performance of payment of the annual fees for remaining years of course payable by the said student is required.

We(Name & Branch of Bank) (hereinafter referred as "the Bank") at the request of(the said student) do hereby undertake to pay the college an amount not exceeding Rs(Rs. only) against dues of annual fees payable to the college by the said student for Three and Half Years (36,75,000/-) for MBBS course at SSIMRC, T-Begur and under any of the following circumstances –

- (a) When student fails to deposit the regular annual fee in the time-frame before last date of payment prescribed by Sri Siddhartha Institute of Medical Sciences and Research Center (SSIMS&RC), T-Begur.
- (b) When student has discontinued and not pursuing his / her studies due to any reason whatsoever, the entire fee for remaining years will be immediately payable to Sri Siddhartha Institute of Medical Sciences and Research Center, T-Begur, Nelamangala, Karnataka.
- (c) When student has been rusticated due to misconduct or any disciplinary action or criminal act on his part, the entire fee for remaining years will be immediately payable to Sri Siddhartha Institute of Medical Sciences and Research Center, T-Begur.

The fees will be paid on due dates as mentioned above, failing which the Bank Guarantee will be encashed by the college.

3. We, the(Name & Branch of Bank) do hereby undertake to make part payment also in each year (when required) against this guarantee as and when demanded by Sri Siddhartha Institute of Medical Sciences and Research Center, T-Begur, Nelamangala, Karnataka.

4. We, the(Name & Branch of Bank) do hereby undertake to pay the amount due and payable under this guarantee without any demur merely on a demand from the college stating that the amount claimed is due from the said student. Any such demand made by the college on the Bank shall be conclusive as regards the amount due and payable by the Bank to the College under this guarantee. However our liability under this guarantee shall be restricted to an amount not exceeding Rs. (Rupeesonly).

5. We undertake to pay to Sri Siddhartha Institute of Medical Sciences and Research Center, T-Begur, Nelamangala, Karnataka any money so demanded notwithstanding any dispute or disputes raised by the student in any suit or proceeding pending before any court or Tribunal relating thereto, our liability under this present being absolute and unequivocal. The payment will be made by us to Sri Siddhartha Institute of Medical Sciences and Research Center, T-Begur, Nelamangala, Karnataka and the student shall have no claim against us for making such payment.

6. We, the (Name & Branch of Bank) further agree that the guarantee herein contained shall remain in full force and effective during the period that would be taken for the performance of the said Admission and that it shall continue to be enforceable till all the dues of Sri Siddhartha Institute of Medical Sciences and Research Center, T-Begur, Nelamangala under or by virtue of the said Admission have been fully paid and its claims satisfied or discharged or till 31st Aug. 2020 and the college certifies that the terms and conditions of the said Admission have been fully and properly carried out by the said student and accordingly discharge this guarantee.

7. The Bank Guarantee shall remain in force up to 31st May. 2024. Unless a claim is lodged with the bank within three months from the said date i.e. by 31st Aug. 2024, this guarantee shall be forfeited and the Bank shall be relieved and discharged for all liabilities there under.

8. This guarantee will not be discharged due to the change in the constitution of the bank.

9. We the (Name & Branch of Bank) lastly undertake not to revoke this guarantee during its currency except with the previous consent of Sri Siddhartha Institute of Medical Sciences and Research Center, T-Begur, Nelamangala, Karnataka.
