As per the Direction of Hon'ble Supreme Court Order, National Eligibility and Entrance Test (NEET) conducted by CBSE for the purpose of admission to 1 year MBBS & BDS courses held on 24<sup>th</sup> July 2016. As per the direction, SSAHE invited applications from NEET qualified candidates for admission to MBBS / BDS courses to our constituent college's viz., Sri Siddhartha Medical College and Sri Siddhartha Dental College and published the merit list prepared on the basis NEET-2016 result.

Candidates should be ready with the Demand Draft to participate in the counseling process for the seat selection. Otherwise they will not be allowed to participate in the seat selection process. **Cash or Cheques are not accepted.**

**Documents to be produced at the time of Counseling:**

It is compulsory that the candidates will have to furnish the following documents at the time of counseling (Originals and Four set of SELF ATTESTED photocopies)

1. SSAHE Merit Card
2. SSLC / X / 10<sup>th</sup> Std marks card for proof of age.
3. II PUC or 12<sup>th</sup> standard or equivalent marks card
4. Study Certificate of PUC – II / 10 + 2 / HSC from institute where student has last studied.
5. Caste certificate issued by competent authority (not less than Tahashildar) in case of SC/ST/OBC candidates.
6. Six recent passport size colour photographs with name written on the back.
7. Four set of photo copies of all the documents (Sl. 1 to 5)
8. Demand Draft towards the Annual Tuition and Other fees, drawn in favour of

**Documents to be produced at the time of admission:**

The candidates are required to submit the following at the time of admission in the college:

1. Allotment Letter issued by the SSAHE.
2. Transfer certificate.
3. Migration certificate.

**Process of counseling:**

The following procedure is followed during counseling:

- a) Registration and verification of documents will be done between 9.00 am to 11. am. Counseling starts at 11.00 am
- b) The registered candidates after the verification of the documents will be allowed for seat selection as per SSAHE merit
- c) The candidate will be issued a provisional letter of allotment after the seat selection.  
(Allotment letter is fully provisional and is subjected to meeting of all eligibility criteria prescribed by authority)

**Admission to the college:**

The candidate will have to join the respective college on or before 19<sup>th</sup> September 2016, failing which the allotted seat will be forfeited.

**Grounds for rejection of counseling:**

- Improper / Incomplete documents.
- Fail to produce D.D for tuition and other fees.
- Absence of the candidate for counseling in person.
- Failed to register within the time specified.

**Refund of fee paid**

The Candidate who do not join the college within the prescribed time and wants to surrender their seat, in such cases the fee will be refunded after making deduction of Rs.5000/- as processing charges.

For surrendering the seats candidate will have to submit a written application, original allotment letter and also the notarized affidavit on a stamp paper with in the specified time.
