## NOTIFICATION

### **UG Medical (MBBS) Admission - 2020 at Sri Siddhartha Medical College, Tumkur, for Unfilled NRI Quota Seats**

(Subjected to Hon'ble Supreme Court of India /DGHS/NMC/MCC)

Sri Siddhartha Academy of Higher Education invites your kind attention to an admission counseling of 2<sup>nd</sup> Mop-Up stray vacant seats in MBBS programs offered by Sri Siddhartha Medical College (SSMC), Tumkur after the Mop-Up rounds conducted by the Central Counseling Authority, Directorate General of Health Services, (DGHS) The counseling will be conducted as per their instructions.

#### **1). Report and Counseling cum Admission Schedule:**

The interested eligible candidates shall report to counseling, along with either of the parent requisite fees and original documents as shown below. The admissions will be granted to the candidates on the basis of inter-se merit amongst the candidates present on the said date and time. No cancellation will be entertained after this admission.

**2). Counseling Procedure:** Candidates attending counseling should satisfy the eligibility requirement as per the UG NEET - 2020 Information Brochure of SSAHE and the minimum eligibility requirements as prescribed by the National Medical Commission regulations for admission to UG Medical courses.

(A). Come prepared for Counseling: The following original documents are to be Submitted for verification during Counseling:

- 1) Registration Slip (Candidate can generate their 'Registration Slip' by logging-in their application / registration form and print the same from MCC portal)
- 2) NEET UG 2020 Qualified Marks / Rank Card
- 3) S.S.C. / 10<sup>th</sup> Standard Statement of Marks
- 4) H.S.C. / 12<sup>th</sup> Standard / Equivalent Examination Statement of Marks
- 5) Leaving / Transfer Certificate
- 6) Bonafide and Character Certificate from Head of Institution last attended.
- 7) Certificate of Age (S.S.C. or 10<sup>th</sup> Passing Certificate / Valid passport)
- 8) Caste & Caste validity certificate (by candidates belonging to all Backward class)
- 9) Aadhar Card of the student – Copy
- 10) Migration certificate - Original + 3 copies (other than Karnataka board candidates)
- 11) Physical fitness certificate
- 12) 8 passport size and 8 stamp size photos
- 13) Bank Guarantee (Annexure-I) - As per format furnished in MCC/SSAHE website for the rest of the course fees payable.
- 14) Three self attested photo copies separate sets of above all documents as per above sequence
- 15) Demand Draft/s of Tuition Fee, Other Fee and University Fee

*In addition to the above, the NRI Applicants would have to submit the following additional documents.*

- 1) Affidavit of the person who is NRI and the sponsorer.
- 2) Documents claiming that the sponsorer is an NRI (Passport, Visa of the sponsorer)
- 3) Affidavit from the sponsorer that he/ she will sponsor the entire course fee of the candidate.
- 4) Embassy Certificate of the Sponsorer.
- 5) Citizenship of the candidate if holding OCI/PIO
- 6) Relationship with NRI with the candidate as per the court order of Hon'ble Supreme court of India in the case W.P (C) no. 689/2017 – Consortium of Deemed Universities in Karnataka (CODEUNIK) & Anr. Vs Union of India & Ors dated 22.08.2017
- 7) The degrees/Certificates of the candidates must have been recognized and approved by the Association of Indian Universities (AIU) if the qualifying examination is other than the 10 + 2 of India.

The candidates who are claiming to be eligible for admission under NRI quota, has to fulfill the eligibility criteria, as per the directions/orders of the Hon'ble Supreme Court of India

**Who can sponsor under NRI Seat:**

Sl. No.	Eligibility
1	Mother or Father of the student
2	Real Brother and Sister of the student
3	Real Brother and sister of Father or Mother i.e real uncle and real aunt of the student
4	Father and Mother of Father or Mother of the student i.e. Grand parents
5	First degree – paternal and maternal cousins of the student.

**Important Note: NRI Applicants:**

- 1) The person sponsoring should hold NRI status and residing abroad and such person should have looked after the student as the guardian. A Notarized Affidavit to that effect should be submitted at the time of admission on a twenty rupee stamp paper.
- 2) NRI quota shall include Overseas Citizens of India (OCI) and Persons of Indian Origin (PIO)
- 3) Course Fee as mentioned in the schedule should be paid in US Dollars. If It is paid in INR, then it should be paid through the NR Account of the sponsorer

**IMPORTANT NOTE:**

There will be active verification of the NEET All India Rank (UR) submitted by the candidate with the information available in the NEET website (ntaneet.nic.in). Candidate whose NEET All India rank does not match with the information in the NEET website will be disqualified from the counseling process.

**B) On the day of Counseling:**

The physical presence of the candidate at the counseling is mandatory.

- a) Only the candidate & one parent will be allowed into the counseling hall
- b) Candidate should sign the attendance register to mark their presence and submit the photo copies of the relevant documents at the registration counter. (as mentioned in 2(A)).
- c) Candidates will be called as per their NEET UG All India Rank 2020 for document verification. Successful candidates will be allotted seats according to their All India NEET (UR) rank and number of seats available. Such candidates should produce their original documents for verification and pay the first year fees & Bank Guarantee at the time of counseling. SSAHE will not entertain any requests for extension in this regard.

- d) Absence of the candidate at the indicated reporting time and date will result in the instantaneous forfeiture of any claim for a seat.
- e) The choice of course/campus made by the candidate is final and binding and cannot be altered later under any circumstances. Once candidates get admitted to MBBS / BDS course cannot withdraw / cancel under any circumstances.

**C) After Admission:**

- a) Admission order/Provisional Admission Order and receipt/s for the payment made will be given to the candidate on completion of the admission process.
- b) Candidates who require hostel facility should report to Chief Warden of the allotted campus for hostel enrollment. Hostel will be allotted on payment of hostel fees only.
- c) Candidates should report to the college on or before the reporting date mentioned in the admission order.

- (b) When student has discontinued and not pursuing his / her studies due to any reason whatsoever, the entire fee for remaining years will be immediately payable to Sri Siddhartha Medical College, Tumkur, Karnataka or Sri Siddhartha Dental College, Tumkur, Karnataka
- (c) When student has been rusticated due to misconduct or any disciplinary action or criminal act on his part, the entire fee for remaining years will be immediately payable to Sri Siddhartha Medical College, Tumkur or Sri Siddhartha Dental College, Tumkur.

The fees will be paid on due dates as mentioned above, failing which the Bank Guarantee will be encashed by the college.

3. We, the .....(Name & Branch of Bank) do hereby undertake to make part payment also in each year (when required) against this guarantee as and when demanded by Sri Siddhartha Medical College, Tumkur, Karnataka or Sri Siddhartha Dental College, Tumkur, Karnataka
